The Bank hereby declares that the Bank does not have any connection with those two fraudulent webpages with mobile applications. And those mobile applications are not established by the Bank. Please do not click the said URL for download and installation.

The Bank suggests customers taking appropriate measures for ensuring relevant websites of the Bank are visited. Customer should download the official mobile application through official App Store by searching “CMBWLB Custody Mobile App”.

The Bank has reported this fraudulent webpage and mobile application to the relevant regulator(s) and the Hong Kong Police Force.
